On Thursday, September 11, 2025 at approximately 1355 hrs I, P.O. Schuyler Epperson Badge 983 BWC 105266 along with partner P.O. Angelo Rosado Badge 4181 BWC 069351 were dispatched to [REDACTED] for a code 8330 (Bomb Threat) against Michigan Lieutenant Governor Garlin Gilchrist B/M/42 [REDACTED] offices. Dispatch advised that there was an explosive device in the form of a pipe bomb, placed in a doorway, set to explode if the door was opened within 48 hours. Unit responded to location along with Detroit Fire Department's Fire, EMS Medic, and Hazmat Units. For the safety of the surrounding area of the property which was a school, a church, and multiple residential homes, the streets were closed to pedestrian foot and vehicular traffic.

Upon units arrival we carefully canvassed the exterior of the building attempting to gain entry with negative results. Detroit Police Department Bomb Squad, Detroit Police Department Canine, and Wayne State Police Department Canine units arrived to perform exterior, and interior sweeps of the buildings stairways, floors, and roof top with orders from Michigan State Police not to enter the actual office space of Lt. Governor Gilchrist. Code 2501 Lt. Henry arrived on scene and assumed the role of incident command. DPD Bomb Squad, DPD canine, WSPD Canine Units performed bomb sweeps of the outside exterior, interior going floor by floor, all building stairways, and the roof top with negative results. DTS-30 along with DTS-11 held the perimeter as the bomb squad, and canine teams performed bomb sweeps of the building.

MSP arrived and performed a bomb sweep of Lt. Governor Gilchrist's office space and found no explosive devices. MSP called the property clear and safe at approximately 1530 hrs.

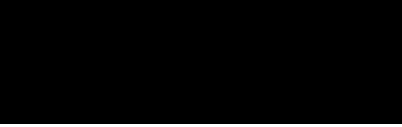

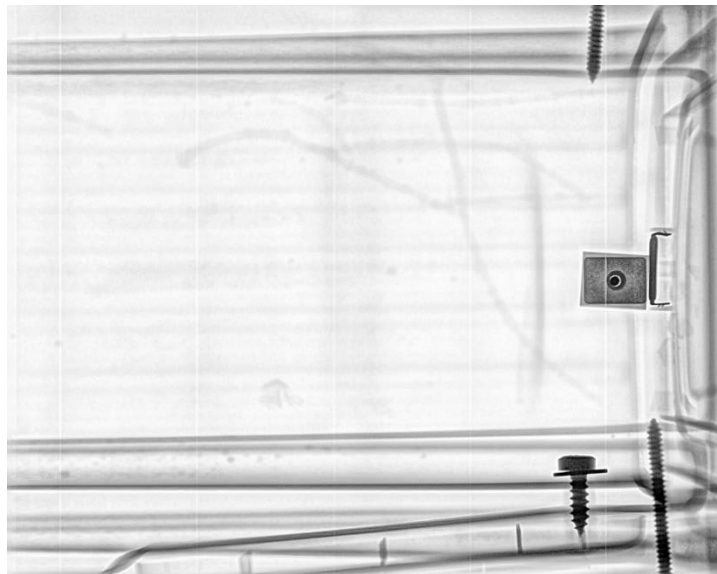
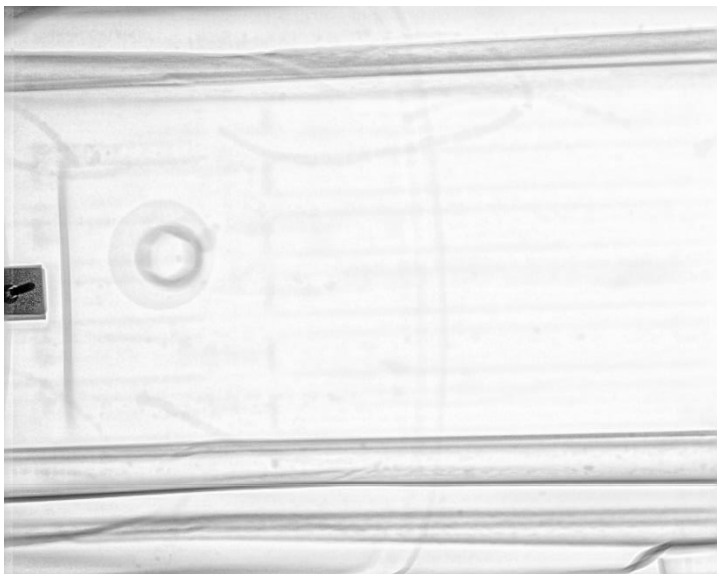

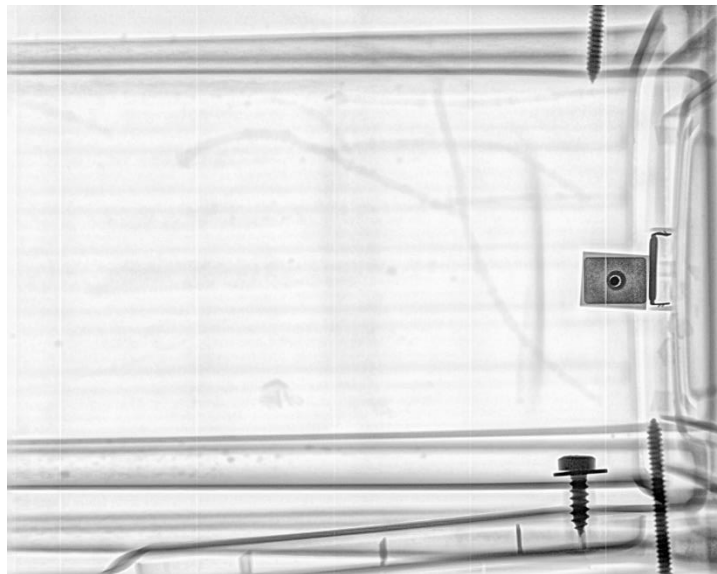
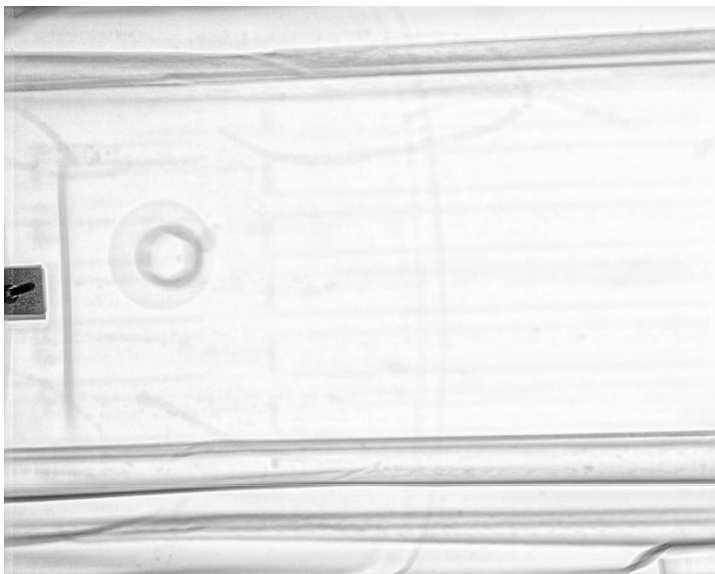
